### **ACTIVITIES**

She graduated from the School for Rural & Surveying Engineering, National Technical University of Athens (NTUA) in 1982, and was awarded with the Technical Chamber of Greece (TCG) scholarship for her academic performance (2nd graduate of the year 1982).

She has received a four-year scholarship from the NTUA to carry out doctoral studies in the fields of Photogrammetry and Cadastre.

The title of her Ph.D. thesis was “Digital Spatial Data for the Hellenic Cadastre”.

During her graduate studies she has worked as teaching assistant in all classes offered by the NTUA in the fields of Photogrammetry, Cadastre, and Cartography.

Also, during that period, she was elected as the graduate student representative at the General Assembly of the School of Rural and Surveying Engineering. In addition, she has contributed to committees related to the development of under graduate and graduate programmes of that School. Since 1992, she has been employed as Special Research and Teaching Scientist at the Lab of Photogrammetry, Topography Division, of the School for Rural and Surveying Engineering, NTUA, at a permanent position.

Currently she participates to the lectures of Cadastre, Photogrammetry and Land Valuation and to the National Technical University’s senate committee for graduate studies.

At the same time, she has been working as a consultant in several research programmes and projects (15 of them at the NTUA and 20 of them at the private and public sector, mainly in cooperation with the Hellenic local authorities, Hellenic Ministries, private and public agencies) in the domains of:

- aerial photography (balloon, helicopter) and compilation of photo mosaics of several Hellenic classic antiquity (ancient walls, temples, graves, theatres and palaces) and archaeological sites for the Hellenic Ministry of Culture (in the areas of Rhodos, Kos, Malia Crete, Ancient Messini, Anihalos, Feres, Pylos, Spata, Thermos, Mecynae, the ancient theatre of Argos, Rethimno Crete)

- terrestrial photography, photogrammetric restitution, field surveying, laser scanning, 3D modelling of cultural monuments and archaeological sites and implementation of Spatial Information Systems for integrated documentation to be used for restoration and development purposes, tourist purposes, scientific studies, etc for the local authorities, such as the old Town Hall of Pireas, the municipality of Thassos island, the Ministry of Culture, the museum of Mycenae, the museum of Olympia, the building of the Italian Embassy in Athens
- archaeological site surveying and documentation in GIS for the French Archaeological School on the island of Crete
- architectural photogrammetry, detailed photogrammetric restitutions of large, complicated cultural monuments and digital photogrammetric documentation of several Byzantine castles, monasteries and churches for the Ministry of Culture and the Archaeological Society of Greece in the areas of Rhodes, Kos, Chios, Feres, Metsovo
- underwater photogrammetry for the Hellenic Institute of Underwater Antiquity at the archaeological area of the island of Docos
