





3) WE HAVE TO TRUST OURSELVES.




DIGITAL AND UP TO DATE DATA

Multipurpose Land Information System



- 2) CADASTRAL WORKS CANNOT BE COMPLETED WITHOUT PRIVATE SECTOR DYNAMISM.






