

- Land registration is an administrative procedure that establishes a complete cadastral file and grants a certificate to legal land users to establish a legal relationship between the State and land users. for the State to strictly manage land according to law and protect the legal rights of land users
- For agro-forestry sectors: Land is a positive element of the production process, a material condition a space base, and at the same time an object of labor (subject to the impact of the production process). export such as plowing, harrowing, turning up, etc., and working tools or means (used for cultivation, breeding ...). The agro-forestry the production process is always closely related to the fertility of natural soil biological processes.
- Therefore, to develop agriculture in a sustainable way, we must first manage land effectively. Must allocate, use each area, each type of land in a way that is suitable for the purpose of land use so as to obtain the highest efficiency.




 Fig.1. Procedures for granting rights to use land in cases of inheritance, donation, purchase, sale or mortgage

Result of issuing land use right certificate

As of September 2018, the first rate of land use right certificates (red book) across the country has reached over 96.9% of the total area of all land types to be granted.

Agricultural production land reached 92.9%

Forestry land reached 98.2%


Aquaculture land reached 86.1%

Rural land reached 96.1%;

Urban land reached 98.3%;

Dedicated land reached 86.9%;

Religious establishments reached 83.6%.

Result of issuing land use right certificate

- According to the Ministry of Natural Resources and Environment (TN&MT), as of December 31, 2018, the country has achieved the rate of granting land use right certificates for the first time, reaching over 97.2% of the total land area need to grant.
- In 3 years (2016-2018), the whole country has put more than 50 thousand hectares of unused land into socio-economic development purposes handled and recovered, canceled more than 1,500 projects with nearly area 30 thousand hectares; complete the arrangement to improve the efficiency of use for 2 million hectares of agricultural and forestry companies; recalled to localities over 400 thousand hectares. At the same time, implementing regulations on land allocation, strengthening land auctions have prevented speculation, increasing revenue from land to over VND 121 trillion, accounting for 12% of domestic budget revenue.

Achievements of land registration for the agricultural sector

- In recent years, Vietnam's land policy has become more and more complete and achieved outstanding achievements such as:
- Successful implementation of the policy of "Land exchange and exchange" creates large sample fields to avoid small and scattered land on households as before, from which people can have enough area. land to build large-scale farms and agricultural technology zones and can bring modern machinery and equipment into agricultural production, leading to increased production efficiency.

Achievements of land registration for the agricultural sector

• According to the 2013 land law, the agricultural land use duration of households and individuals has been increased from 20 years to 50 years. This is also a new point in the land management policy in Vietnam, since this change has made people feel secure in the investment and production process and when investing in large technology of modern equipment. Advantages and disadvantages in issuing land use right certificates


Advantages



Requirement

- Need to simplify administratively procedures
- Remove suspended plans to avoid high value abandoned the land
- Proposing the Government, Ministry of Natural Resources and Environment to continue to improve the legal policy, issue documents to reduce troubles for land users when registering land, granting land use right certificates, reduce fees related to certification to suit actual conditions.
- Propose strengthening inspection and supervision to increase transparency in the management and in the process of land registration
- Must regularly propagate and open training classes to disseminate land laws for officials and people to master the land law, documents, decrees, certification procedures, thereby helping people use land in accordance with planning, plans. improve efficiency, minimize land disputes.
