- Land governance is defined as the political and administrative structures and processes through which decisions concerning access to and use of land resources are made and implemented over land.
- The actual governing involves both formal and informal institutions.
- Communal Land Reform Act- Outlining the responsibilities of TA concerning the governance of land
- Traditional Authorities are the custodians of Indigenous and Local Knowledge.
- Traditional Authorities have a big role in ensuring that traditions are respected and maintained for the benefit of their prosperity
- As custodians of this knowledge system, TAs have the advantage of closing and bridging the gap between local knowledge and Western/Scientific knowledge on climate change strategies.
- TA's should be at the frontline and center in the fight against climate change.

DRAWBACKS AND DIFFICULTIES IN TRADITIONAL AUTHORITIES ADDRESSING CLIMATE CHANGE



1. Loss of Power

The roles of traditional authorities such as influencing land negotiations virtually disappeared with the government and related external authorities taking over these rights

2. Loss of Obligation

Some TAs undermined the efforts of the Government and lawmakers by unlawfully aiding and abetting illegal settlement, environmental predators, natural and at the resource capture of expense local communities.

3. Top-down Approaches
